In accordance with the requirements and extend of the above mentioned policy, cover is given for the liability of the policyholder arising from contracts on the carriage of goods with the motor vehicles of the firm registered with the insurance company.

- by means of permissible cross-border road haulage according to the Convention on the Contract for the International Carriage of Goods by Road (CMR).

- by means of commercial internal German goods traffic, for which a permit is available. Insurance cover for the particular contractual relationship is based on the agreed or statutory liability according to General German Forwarders' Conditions (ADSp), German Conditions for Freight Haulage (VBGL) or the German Commercial Code (HGB), excluding the transportation of removal goods.

In accordance with the extend of the above-mentioned policy, insured is the liability of the policyholder from transportation contracts concerning the provision of the shipment and the storage of goods according to ADSp and the law (liability Insurance according to Clause 29 ADSp).

Insurance expiration 31.12.2026

The contract shall be renewed tacitly each year for 12 month, unless notice of cancellation by either of the contractual partners is given 3 month prior to the expiry of the insured period.

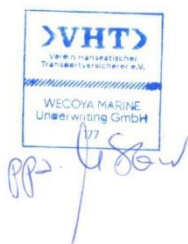
